The number of Arbitrator shall be one. If the Parties cannot mutually agree on arbitrator within 4 weeks, then Institution and RICECITY shall appoint a sole arbitrator. The seat of arbitration shall be Bangalore. The language to be used in the arbitration proceedings shall be English.

13. Commitments:
