#### Introduction

The Vivekananda Institute of Technology has established SC/ST Committee on 26-06-2018. The SC/ST Committee is functioning exclusively for the welfare of the teaching staff, non-teaching staff and students of Vivekananda Institute of Technology.

SC & ST Committee Students from SC/ST are allotted seats as per state government policies. Tuition fees reimbursement, fees exemptions, and endowment benefits are also extended to these students in our institution as per the state government rules.

These students are provided with some extra facilities provided by the college management also.

The institution continuously bestow their efforts to create awareness on the importance of higher studies i.e. education as a means of empowerment to bring change in the society.

The faculty members also explain the various benefits they are getting from the government according to the reservation policies, financial and academic facilities gained through the institution and state government.

#### **Objectives:**

- To guide the SC/ST Students of the Institute to optimally utilise the benefits of the schemes offered by the State Government, Government of India and UGC.
- To assist the staff of the SC/ST Committee and the standing committee is carrying out their entire functions of the Committee.
- To collect the data regarding the implementation of the policy in respect of admission.

#### Functions:

According to the UGC Guidelines of 1996, following are the functions of the Cell to:

- Circulate GOI and Commission's decisions and to collect regularly, on an annual basis, information regarding course-wise admissions to candidates belonging to the Scheduled Castes and Scheduled Tribes in the Universities and Colleges for different courses, in suitable forms prescribed, by a stipulated date, and to take follow up setion, where required:
- Circulate GOI orders and Commission's decisions and to collect information in respect
  of appointment, training of these communities in teaching and nonteaching posts in the
  Universities and Colleges, in suitable forms by a stipulated date and take follow up
  action where required:
- Collect reports and information regarding the GOI orders on the various aspects of education, training and employment of Scheduled Casts and Scheduled Tribs eandidates, for evolving new policies or modifying existing policy by the Commission;
- Analyse information on admissions, education, training and employment of SCs and STs, and prepare reports and digests for onward transmission to the Ministry of Human Resource Development/University Crants Commission and such other authorities as may be required;
- Deal with representations received from Scheduled Castes and Tribes candidates regarding their admission, recruitment, promotion and other similar matters in Universities/Colleges;
- Monitor the working of the remedial coaching scheme, if approved in the affiliated colleges and university;
- Function as a Grievances Redressal Cell for the grievances of SC/ST students and employees of the university and render them necessary help in solving their scademic as well as administrative problems;
- Maintain a register for employment of SCs/STs in the University and Colleges for the
  candidates belonging to SC/ST community for various posts in the university/ colleges;
  and ix. Any other work assigned from time to time to promote higher education among
  these two communities suffering economic, social and educational deprivations.

#### Frequency of Meeting

According to the regulations framed by VKIT, the Committee meets two times in a year in the month of January and August.
